**APPLICATION PROCESS**

Applications must be received (**not postmarked**) between **February 22<sup>nd</sup>, 2010** and **March 19<sup>th</sup>, 2010**. Applications received outside of this time frame will be rejected and not entered into the lottery. **There will be no exceptions!** Only one application per boat may be submitted.

Applications must be submitted on the form provided with this packet or on the Borough Website to the Manasquan Borough Clerk's office, 201 East Main Street, Manasquan, NJ 08736, 2<sup>nd</sup> floor.

The following is required to be submitted with the application: 1) Proof of Residency – if a Manasquan resident and 2) Copy of Valid Boat Registration.

The available number of slips and sizes will be posted in the Clerk's office and posted on the Borough website after March 26, 2010

**LOTTERY DRAWING**

All applicants *may* be present for the drawing which will be held in Council Chambers of Borough Hall, 201 East Main Street, Manasquan, NJ 08736 on **March 29, 2010 at 10:00 a.m.** for **Residents** or on **April 1, 2010 at 10:00 a.m.** for **Non-Residents**.

**LEASING PROCESS FOLLOWING THE DRAWING**

Following the drawing, the successful applicants will be notified of the lottery results by the Municipal Clerk's Office who will call using the phone number(s) listed on the application. The Clerk's Office has the right to select the next applicant in line if:

1. They are unable to contact the successful applicant,
2. If the applicant does not respond to a voice message left by the Clerk, or
3. The applicant neglects to respond to the Clerk's Office to complete the process within the required 5 days.

The following will be required within 5 days of the drawing from the successful applicant to rent the boat dock:

1. Payment of Dock Rental Fee in Cash or by Personal Check,
2. Valid Boat Registration,
3. Proof of Residency if a Resident of Manasquan,
4. Completed Lease Form,\*
5. Completed Boat Slip Information Form,\* and
6. Proof of Insurance

\*Provided by the Clerk's Office to the successful lessees along with the Conditions of Leasing, Board of Health Notice, Parking Sticker (4<sup>th</sup> Ave. only) and Docking Permit Sticker.
